The Deputy Speaker advised the Assembly that nominations were open, and the following Members were nominated and allowed their names to stand for the position of Speaker:

Receiving no additional nominations, the Deputy Speaker declared nominations closed.

Ballots were completed by the Members.

The Clerk, Table Officers, and Sergeant-at-Arms retired from the Chamber to count the ballots.

### **Election Results**

The Clerk then announced the following:

The results of the first ballot for the election of the Speaker are as follows: the number of ballots cast, 84; the number of spoiled ballots, 0; the number of votes required to achieve the 50 percent plus one majority, 43; the Member having received the majority of votes cast, Hon. Mr. McIver. Hon. Mr. McIver is hereby declared Speaker of the Legislative Assembly for the remainder of the 31st Legislature.

The Speaker donned his robe. The Speaker thanked the Assembly for the honour conferred upon him with the following speech:

Thank you. I'm grateful for this honour. I'm grateful for everybody here, for the previous Speaker, the Deputy Speaker, and all the rest. I also want to thank the Member for Edmonton-Manning for putting her name forward.

Folks, despite the fact that I've watched this important place for about 13 years, that doesn't mean I won't mess it up. But with your help, I'll flail along until we get better at it. I'm committed to everybody on both sides, to honour the traditions of this place, to be nonpartisan, and to help us get through the business of the day every day. You know what? If we have a little fun, great. Not too much fun. Better fun than nastiness. When that happens, we'll deal with that, too. It's all part of what we do here.

I'm just so grateful.
