

Guide to the 2012–2013 Speaker Index

Committee mandate: The Select Special Conflicts of Interest Act Review Committee is an all-party committee consisting of 11 members. By December 1, 2012, it must undertake a comprehensive review of the Conflicts of Interest Act, as provided in section 48 of that Act. The Committee must submit to the Legislative Assembly of Alberta, within one year after beginning the review, a report that includes any amendments recommended by the Committee.

There are two indexes for the transcripts of meetings of the Select Special Conflicts of Interest Act Review Committee, a **subject index** and a **speaker index**.
