

Guide to the 2023-2024 Speaker Index

Committee mandate: The Select Special Conflicts of Interest Act Review Committee is a committee of the Legislative Assembly appointed on December 5, 2023, with the passage of Government Motion 10, to review the Conflicts of Interest Act as provided in section 48 of that act. The committee must submit its report to the Assembly, including any amendments to the act recommended by the committee, within one year after commencing its review.

There are two indexes for the transcripts of meetings of the Select Special Conflicts of Interest Act Review Committee, a **subject index** and a **speaker index**. Interim indexes are unedited and are not considered official. Committee activities during the 31st Legislature, First Session (June 20, 2023 –) are as follows.
