

## Guide to the 2020 Speaker Index

**Committee mandate:** The Select Special Democratic Accountability Committee consists of 12 members of the Legislative Assembly. The Committee has been appointed to review matters pertaining to:

- Questions surrounding recall and citizen initiatives, as per Sessional Paper 192/2020;
- the Election Act; and
- the Election Finances and Contributions Disclosure Act.

The Committee must submit its report pertaining to recall and citizen initiatives within four months after commencing its review, and its report pertaining to its review of the Election Act and Election Finances and Contributions Disclosure Act, within six months after commencing its review, to the Legislative Assembly, including any recommendations the Committee wishes to make.

There are two indexes for the transcripts of meetings of the Select Special Democratic Accountability Committee, a **subject index** and a **speaker index**. Interim indexes are unedited and are not considered official. Committee activities during the 30th Legislature, Second Session (February 25, 2020 – ) are as follows.
