

Guide to the 2022 (Third Session) Speaker Index

Committee mandate: The Standing Committee on Alberta's Economic Future is a legislative policy committee with a mandate that relates to the areas of Advanced Education, Culture, Multiculturalism and Status of Women, Jobs, Economy and Innovation, Labour and Immigration and Infrastructure.

On June 15, 2021, the Legislative Assembly passed Government Motion 86, which referred the Lobbyists Act to the Standing Committee on Alberta's Economic Future for review pursuant to section 21 of the Lobbyists Act. The committee must submit its report to the Assembly within one year after beginning its review, and that report is to include any amendments recommended by the committee.

There are two indexes for the transcripts of meetings of the Standing Committee on Alberta's Economic Future, a **subject index** and a **speaker index**. Interim indexes are unedited and are not considered official. Committee activities during the 30th Legislature, Third Session (February 22 – October 30, 2022) are as follows.
