

## Guide to the 2012-14 Speaker Index

**Committee mandate:** Standing Committee on Legislative Offices is an all-party committee consisting of 11 Members of the Legislative Assembly. The committee approves the budgets of the Officers of the Legislature, including the Auditor General, the Chief Electoral Officer, the Ombudsman, the Ethics Commissioner, the Information and Privacy Commissioner, and the Child and Youth Advocate and also reviews the salaries of the officers on an annual basis. The committee can entertain officers' requests regarding proposed changes to legislation and forward the recommendation to the appropriate ministry. However, the committee does not have the mandate to approve changes to legislation.

There are two indexes for the transcripts of meetings of the Special Standing Committee on Legislative Offices, a **subject index** and a **speaker index**. Committee activities during the 28th Legislature, First Session (May 23, 2012–) were as follows.

The committee has reviewed the officers' salaries for 2012-13 and 2013-14, approved the salary of the Deputy Chief Electoral Officer for 2013-14, reviewed a request from the office of the Chief Electoral Officer for supplementary funding, and heard overview presentations from the officers.
