

## Guide to the 2019-2020 Subject Index

**Committee mandate:** The Standing Committee on Legislative Offices comprises 11 Members of the Legislative Assembly. The committee approves the budgets of the Officers of the Legislature, including the Auditor General, the Child and Youth Advocate, the Chief Electoral Officer, the Ethics Commissioner, the Information and Privacy Commissioner, the Ombudsman, and the Public Interest Commissioner, and also reviews the salaries of the Officers on an annual basis. The committee can entertain Officers' requests regarding proposed changes to legislation and forward the recommendation to the appropriate ministry. However, it is important to note that the committee does not have the mandate to approve changes to legislation.

There are two indexes for the transcripts of meetings of the Standing Committee on Alberta's Economic Future, a **subject index** and a **speaker index**. Interim indexes are unedited and are not considered official. Committee activities during the 30th Legislature, First Session (May 21, 2019 – February 24, 2020) are as follows.
