

Guide to the 2011 Speaker Index

Committee mandate: The Standing Committee on Private Bills is an all-party committee consisting of 21 Members of the Legislative Assembly that reviews all petitions for private bills and reports to the Assembly on that review. The committee hears from the petitioner and any other persons interested in the bill and reports to the Assembly.
