

## Guide to the 2010 Speaker Index

**Committee mandate:** Standing Committee on Public Safety and Services is an all-party committee consisting of 12 Members of the Legislative Assembly. Its mandate relates to the areas of aboriginal relations, government services, government organization, personnel administration, expenditure management, revenue, justice, policing, and public security.
