### Guide to the 2015-2016 Speaker Index

**Committee mandate:** The Standing Committee on Resource Stewardship is an all-party committee consisting of 15 Members of the Legislative Assembly. It may meet to review a bill or to consider an issue referred to it by the Assembly, and can also meet on its own initiative to consider issues within its mandate.
