On July 2, 2019, the Public Sector Compensation Transparency Act was referred to the Standing Committee on Resource Stewardship pursuant to Government Motion 25. The committee began a comprehensive review of the act on July 22, 2019, and must submit a final report to the Legislative Assembly within six months of this date.
