

Guide to the 2025-2026 Speaker Index

Committee mandate: The Standing Committee on Resource Stewardship is a legislative policy committee with a mandate related to the areas of affordability and utilities, energy and minerals, environment and protected areas, forestry and parks, Indigenous relations, municipal affairs, transportation and economic corridors, and Treasury Board and finance.

On May 13, 2025, the Public Interest (Whistleblower Protection) Act was referred to the Standing Committee on Resource Stewardship pursuant to Government Motion 73, 31st Legislature, First Session. In accordance with section 37 of the act the committee must submit its report to the Assembly within one year after beginning its review, and that report is to include any amendments recommended by the committee.

There are two indexes for the transcripts of meetings of the Standing Committee on Resource Stewardship, a **subject index** and a **speaker index**. Interim indexes are unedited and are not considered official. Committee activities during the 31st Legislature, Second Session (October 23, 2025 –) are as follows.
